

## Application for Membership and for Electric Service

The undersigned (hereinafter called the "Applicant") hereby applies for membership in, and agrees to purchase electric energy from Southern Illinois Electric Cooperative (hereinafter called the "Cooperative"), upon the following terms and conditions:

1. The Applicant will pay to the Cooperative the sum of \$5.00, which, if the Cooperative accepts this application, will constitute the Applicant's membership fee.
2. The Applicant will, when electric energy becomes available, purchase from the Cooperative all electric energy used on the premises described below and will pay therefore monthly at rates to be determined from time to time in accordance with the by-laws of the Cooperative; provided, however, that the Cooperative may limit the amount of electric energy to be furnished for industrial uses. The Applicant will pay a bill of at least \$\_\_\_\_\_ per month regardless of the number of kilowatt ours consumed.
3. The Applicant will cause his premises to be wired in accordance with the applicable state and local electrical codes and in compliance with the rules and regulations of the Cooperative. The Applicant's house is approximately \_\_\_\_\_ feet from proposed distribution line and \_\_\_\_\_ feet from the nearest public road.
4. The Applicant will comply with and be bound by the provisions of the certificate of incorporation and by-laws of the Cooperative, and such rules and regulations as may from time to time be adopted by the Cooperative. The Applicant agrees to pay attorney fees, cost and expenses in the event the Cooperative is required to retain legal counsel to enforce the rules and regulations of the Cooperative or to collect the applicant's electrical bill.
5. The Applicant, by paying a membership fee and becoming a member, assumes no personal liability or responsibility for any debts or liabilities of the Cooperative, and it is expressly understood that under the law his private property cannot be attached for any such debts or liabilities.

The acceptance of the application by the Cooperative shall constitute an agreement between the Applicant and the Cooperative, and the contract for electric service shall continue in force for one year from date service is made available by the Cooperative to the Applicant, and thereafter until cancelled by at least 30 days written notice given by either party to the other.

Applicant agrees that assessments for electric energy shall include payment for a subscription to the ILLINOIS COUNTRY LIVING, or its successor publication, published by the Association of Illinois Electric Cooperatives.
